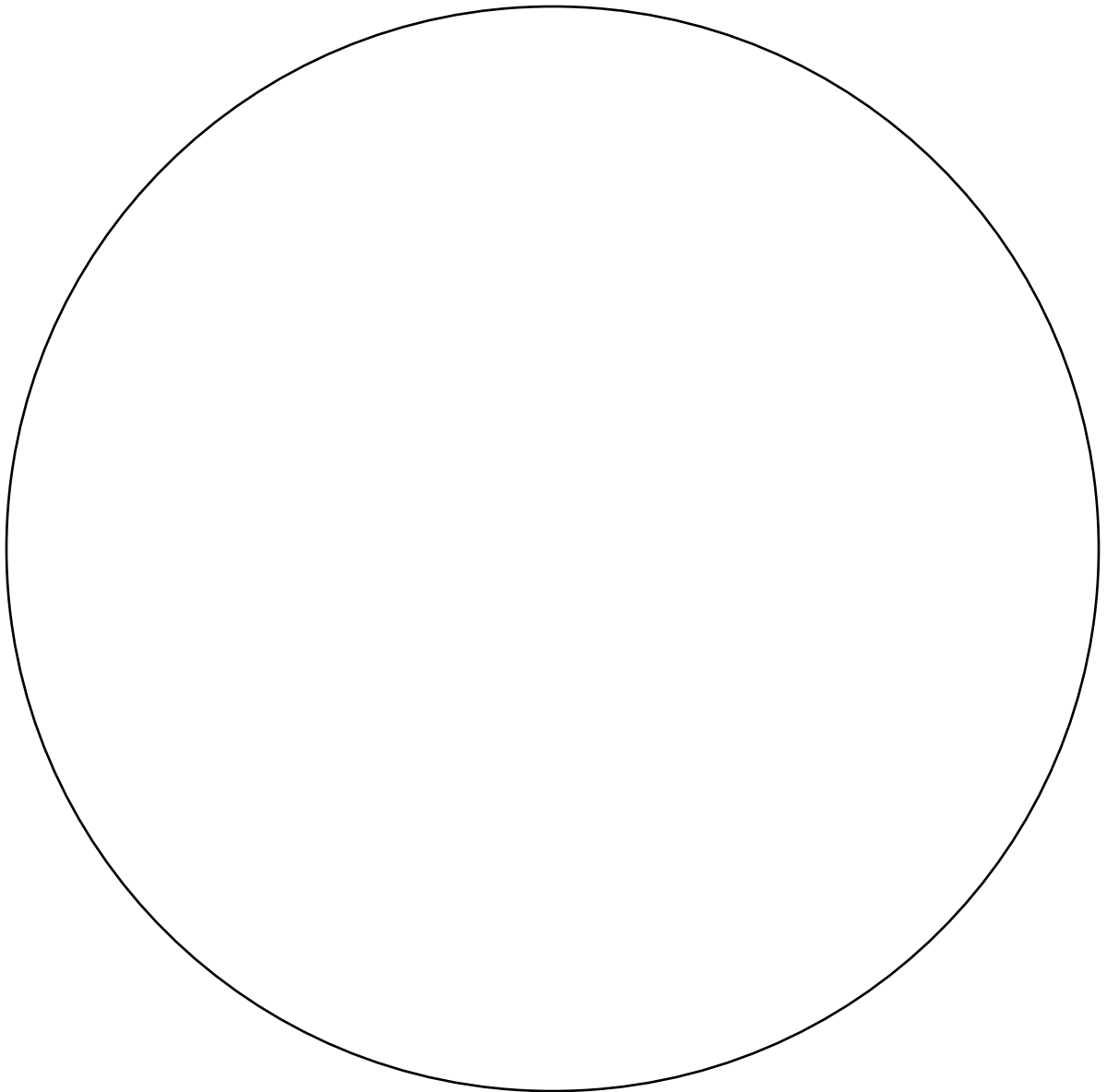

I Voted Sticker Design Parent Consent Form

By signing this Parental Consent Form:

1. I hereby agree that my minor child may participate in the "I Voted" Sticker Design Contest being sponsored by the Greene County Clerk's Office and KY3 (collectively the "Sponsor"), and irrevocably grant my permission and authorize the Sponsor to use my minor child's name, school, artwork, and photograph for purposes of the contest. I also agree that my child's name, school, artwork, and photograph will be used in advertising, marketing, and promoting the contest, and to reproduce and publish the same throughout the universe in perpetuity, in any and all media now known or hereinafter devised. I further agree that the contest, my minor child's participation in the contest and all of the contest elements belong entirely and exclusively to the Sponsor, so that the Sponsor and its licensees and assigns may duplicate, distribute, broadcast, exhibit, or otherwise use the contest without limitation or restriction throughout the universe in perpetuity. The Sponsor may edit and adapt my child's participation as it deems appropriate.
2. I understand and agree that neither I, nor my minor child, will own any rights in the contest or the contest elements, or receive any monetary compensation relating thereto. I am granting the Sponsor a free, non-exclusive, irrevocable license to use my minor child's name, school name, artwork, and photograph to fulfill the purpose of the contest. I acknowledge that the Sponsor shall have no obligation at all to use my minor child's information in the contest.
3. I agree that neither I, nor my minor child, shall make any claims against the Sponsor based upon distribution of the material or the contest and its elements to which I have consented on behalf of my minor child. I release the Sponsor and its licensees and assigns from any and all claims and liabilities whatsoever that may occur in relation to or arising from my minor child's participation in the contest. I agree that this consent and release will be governed by and construed in accordance with the laws of the State of Missouri.
4. I confirm that my minor child lives in the United States of America, State of Missouri, and County of Greene.
5. I agree that my minor child may participate in the contest described in the Official Rules and I confirm and agree to be bound by the Official Rules, including, but not limited to, the indemnity provisions.
6. I understand my minor child's name and other information that I provide on behalf of or related to my minor child, as described in the Official Rules, may be posted together with my minor child's submission upon the Sponsor's website and social media platforms, as well as other public forums, such as the media, without any additional notice to or permission by me.
7. I hereby warrant that I am a legal competent adult and a parent or legally appointed guardian of the minor child named below, and that I have every right to contract for the minor child in the above regard.
8. I certify and acknowledge that I have read, understood and agree to the Official Rules of the contest, and that I have read this Parental Consent Form prior to signing it; that I have the full authority to give my consent and release so that my minor child may participate in the contest and that I consent to provide the information concerning my minor child that is necessary to enter the contest and if selected, to be awarded a finalist or winner.

Accordingly, and intending to be legally bound, I voluntarily agree to the terms set forth herein and acknowledge and agree that my minor child and myself are bound by the Official Rules and I am bound by the terms of this Parental Consent Form. This release shall be binding upon my minor child, me and our respective heirs, legal representatives, and assigns.

I Voted Sticker Design Contest Rules

The "I Voted" Sticker Contest is sponsored by the Greene County Clerk's Office and KY3. Elementary students that reside in Greene County are invited to submit their sticker designs from February 1, 2024 through April 1, 2024. A panel of judges (high school art students nominated by high school art teachers) will review and select 5 finalists.

By submitting an entry, you agree to be bound by the following "Official Rules" of the contest:

1. SPONSOR:

- This contest is sponsored by the Greene County Clerk's Office and KY3 (collectively referred to as the "Sponsor").

2. ELIGIBILITY:

- Must be a resident of Greene County, Missouri to enter
- Must be currently enrolled in Kindergarten through 5th Grade (or the equivalent for homeschooled students)
- Immediate family members of the Sponsor or members of their household are not eligible to participate
- Only one entry per person may be submitted

3. HOW TO ENTER:

- The contest will begin on February 1, 2024. To enter you must submit your artwork and Design Entry Form electronically at vote.greenecountymo.gov or at the Greene County Clerk's Office (940 N Boonville Ave, RM 113, Springfield, Missouri, 65802) in-person or by mail. Minors under 18 years of age will also need to complete a Parental Consent Form. All artwork must be received by 11:59PM on April 1, 2024 via online, in-person or by mail. Late entries will not be accepted, including mailed submissions. One entry per contestant. No entry fee is required to participate in the contest.

4. DESIGN REQUIREMENTS:

- Contestants must create an original design that corresponds with the theme of voting and elections. All submissions:
 - MUST use one of the provided circular template
 - MUST include the words "I Voted"
 - MUST be original artwork
 - MUST fit on a circular sticker two inches in diameter.

Submissions may be hand-drawn using pencil, pens, crayons, markers, paint or other mixed media tools, or created using graphic design software. To accommodate print quality, designs should be submitted as high-resolution JPG, PNG, or PDF file types. The

Sponsor may require the original artwork of the finalists to be submitted for print quality purposes, therefore Contestants should maintain their original artwork.

5. PUBLIC VOTING:

- Once all submissions are received, a panel of judges (high school art students nominated by high school art teachers) will review and select 5 finalists. From those 5 finalists, the members of the general public may vote online for their sticker of choice. The public voting period will begin around April 15, 2024 and end on April 19, 2024. The finalist design that receives the most votes during the voting period will be the winner. The judges' overall scores when selecting finalists will be used to determine the winner in the event of a tie.

6. VOTING RULES:

- Finalists are encouraged to tell family and friends about the competition and ask them to participate in voting online. Activity that deems to be fraudulent, unfair or unethical is not permitted and may result in the removal of a design entry or disqualification of a contestant.

7. CONTEST WINNER:

- The winner's artwork design will be used as the official "I Voted" Sticker of Greene County, Missouri for the August and November 2024 Elections at a minimum.
- The name (first name and last initial) and artwork of the finalists may appear on media outlets such as television, radio, and newspaper and their respective social media platforms.

8. TERMS AND CONDITIONS

Any person submitting a sticker design to the Greene County Clerk's Office for the "I Voted" Sticker Design Contest agrees to legally be bound by these Terms and Conditions and to release the Sponsor from any and all claims of liability:

1. The Sponsor does not claim ownership to the contest entries. Contestants must attest to ownership and rights to their design and permanently transfer and assign all ownership and rights to their works to the Greene County Clerk's Office for future use and distribution. By entering the contest, Contestants consent to being publicly named by first name and last initial, photograph by the Sponsor and its affiliates, subsidiaries, parents and licensees in connection with all promotional and educational material about the sticker and the contest.
2. By submitting an entry, you agree that your entry is your original artwork.
 - a. It does not contain words or images that are obscene, inappropriate, or defamatory, according to the judgement of the Sponsor.
 - b. It does not infringe or violate the copyrights, trademarks, rights of privacy, publicity, or other rights of any person or entity.
 - c. It does not contain malicious code, such as viruses, timebombs, cancelbots, worms, Trojan horses, or other harmful programs or information.
 - d. It does not and will not violate any law, statute, ordinance, rule or regulation.
 - e. It does not feature the likeness or private individuals without the individuals' express written permission for its use.

- f. It does not trigger any reporting or royalty obligation to any third party.
 - g. It does not contain any words, symbols, or images that are partisan in nature to any political party, ideological thought, or controversial issue.
- 3. Submission of a sticker design in the contest does not obligate the Greene County Clerk's Office to use that sticker design.
- 4. The Sponsor is not responsible for incomplete, late, lost, delayed, damaged, misdirected, void, corrupted, garbled, illegible, or unintelligible submissions.
- 5. Submissions may require minor design changes to fit the printing requirements. Contestants will not have the authority to review or approve the final art submitted for printing.
- 6. By submitting an entry, you agree to release and hold harmless the Sponsor, and any other organizations responsible for sponsoring, fulfilling, administering, advertising, or promoting the contest, and all of their respective past and present officers, directors, employees, agents and representatives ("Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a contestant's entry, creation of an entry or submission of an entry, participation in the contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, transmission, performance, exploitation or use of entry and hold harmless the Sponsor from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to a contestant's participation in the contest and/or contestant's acceptance, use or misuse of prize. The parties acknowledge that one of the Sponsors is a governmental entity entitled to certain immunities under the doctrines of sovereign, official, and governmental immunity. In no event shall the language of these rules constitute or be construed as a waiver or limitation of the Sponsor's rights or defenses regarding any applicable sovereign, governmental, or official immunities and protections provided by Federal and State Constitutional Law.
- 7. The Released Parties are not responsible for any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the contest; or technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; unauthorized human intervention; or technical or human error which may occur in the administration of the contest.
- 8. Contestants agree that any and all disputes, claims and cause of action arising out of or connected with this contest, other than those concerning the administration or the contest or the determination or the winner, shall be resolved individually, without resort to any form of class action; any and all disputes, claims and causes of action arising out of or connected with this contest, or any prizes awarded, shall be resolved solely and exclusively in the Circuit Court of Greene County, Missouri; and any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this contest, but in no event attorney's fees;
- 9. Contestants will receive no financial compensation for their submission.
